**What’s the deal?**

You agree to pay £5 a month by standing order (or £60 annually by cheque) and EACH MONTH we retain half for the project and pay back half the subscriptions as Prize Money. That means that if there were 200 members, each month we will raise £500 for the project and there will be monthly prizes of:

1st Prize	£250
2nd Prize	£150
3rd Prize	£100

**Who can join?**

Anyone over the age of 18 years.

**How can I join?**

Just fill in the form overleaf and return it to the administrator, whose details are shown below. PLEASE DO NOT send the form to your bank. You will be allocated a membership number which will go into each monthly draw. If you want more than one number you will need to complete a separate mandate form for each one.

**How will the draw take place?**

The winning entries will be drawn on the second Thursday of each month.

**How will I know I’ve won?**

**Rules and Objectives**



1. The Club shall be known as the "Fishbourne 50/50 Club "
2. The objective of the Club shall be the provision of funds for the Fishbourne Community Project
3. The control of the Club and its funds shall be the responsibility of the Fishbourne Parish Council.
4. The Club shall initially be restricted to 200 members.
5. Membership of the Club shall be available to any person over the age of 18 years, whether or not they live in the Parish of Fishbourne.
6. The cost of membership shall be £5 per month payable by Standing Order on the 1st day of each month. Three months' written notice of withdrawal is required.
7. There will be no restriction on the number of tickets held per member. Draw numbers will be allocated on receipt of application and will remain in place throughout the duration of the Club.
8. The monthly draw will take place on the 2nd Thursday of each month Three prize winning numbers will be drawn and prizes will be paid by cheque,.
9. Prize money shall represent 50% of membership contributions for the month and will be allocated as follows:
 

First prize	25% of subscriptions
Second prize	15% of subscriptions
Third prize	10% of subscriptions

The balance of 50% of subscriptions will be applied for the benefit of the Fishbourne Community Project.  
Prize winners will be notified and sent a cheque by post.
10. The Club will maintain a list of prize-winners for all members to see and winners' names will be posted on a notice board at the Fishbourne Centre and on the web site of the Fishbourne Centre ([www.fishbournecentre.org.uk](http://www.fishbournecentre.org.uk))
11. Personal information will be used only for the administration of the Club, including the operation of the draw. Under the Data Protection Act 1998 you have a right to access personal data that we hold about you (this is called a "subject access request")
